4) Late Fees & Late Pick-Up Fees

A Late fee of \$5.00 will be applied to payments not received by close of business on the Friday prior to service. Families may pay by cash or check. There is a \$35.00 fee for all checks that require a re-deposit.

Kid Angles closes at 5:30p.m. **A late pick-up fee of \$2.00 per minute will be charged to the family's account for each minute parents and/or children are INSIDETHE BUILDING after 5:30p.m.** Late pick-up fees are due with the next tuition payment. This procedure is necessary to cover the cost of staff's extra time on duty. Please call to notify us if you are running late so that we can prepare your child and staff for the delay.

5) Two Week Notice

Families must give a written notice two weeks before withdrawing a child/children from Kid Angles. If a two week notice is not given, Kid Angles will charge payment for two weeks.

Kid Angles reserves the right to give a written notice and take action when fees are not paid. If fees are not rectified, Kid Angles will take the issue to small claims court where court & attorney fees and loss of income will also be added to the family's bill.

Providing false information could be grounds for termination of childcare services, forfeiture of deposit, or both.
